## Specialty distribution process

A specialty distributor is a wholesale pharmaceutical distributor that buys and ships drugs that require special handling and support.

Once the prescribing healthcare provider makes the decision to treat, TEPEZZA can be ordered through the following buy and bill process:

### 1. Complete benefits and procurement verification through the patient's insurance on your own or with help from Horizon Patient Services

- Verify benefits and procurement options
- Complete prior authorization submission, if required
- Confirm payment mechanisms to ensure the order can move forward
- Payer requirements and/or HCP preferences may determine the site of care

### 2. Site of care will process the order with the specialty distributor

- Confirm an existing account or set up a new account with one of the authorized specialty distributors. Reference the TEPEZZA NDC number (75987-130-15)<sup>1</sup> on the product fact sheet
- Call the specialty distributor to complete the order

### 3. Site of care will coordinate scheduling of TEPEZZA administration with product delivery

### 4. Specialty distributor ships TEPEZZA to site of care

### 5. Submit claims for TEPEZZA and the administration of treatment

## Specialty pharmacy process

A specialty pharmacy dispenses and offers support services for specialty drugs that typically treat complex conditions or require special handling.

Once the provider makes the decision to treat, the preferred and most efficient method of ordering is to submit the prescription through Horizon Patient Services™. TEPEZZA can also be ordered through the following buy and bill process:

### 1. Complete benefits and procurement verification through the patient's insurance on your own or with help from Horizon Patient Services

- Verify benefits and procurement options
- Complete prior authorization submission, if required
- Payer requirements and/or HCP preferences may determine the site of care

### 2. Site of care will request that the prescriber send the prescription on the enrollment form to Horizon Patient Services or Accredo

### 3. Work with Accredo to verify insurance approval

- Accredo may contact your practice for additional documentation and final submission
- If a prior authorization is required for TEPEZZA, include a letter of medical necessity and supporting documents when providing a prescription or referral form

### 4. Specialty pharmacy ships TEPEZZA to site of care

### 5. Submit claims for the administration of TEPEZZA

TEPEZZA is indicated for the treatment of Thyroid Eye Disease.

## IMPORTANT SAFETY INFORMATION

### Warnings and Precautions

**Infusion Reactions:** TEPEZZA may cause infusion reactions. Infusion reactions have been reported in approximately 4% of patients treated with TEPEZZA. Reported infusion reactions have usually been mild or moderate in severity. Signs and symptoms may include transient increases in blood pressure, feeling hot, tachycardia, dyspnea, headache, and muscular pain. Infusion reactions may occur during an infusion or within 1.5 hours after an infusion. In patients who experience an infusion reaction, consideration should be given to premedicating with an antihistamine, antipyretic, or corticosteroid and/or administering all subsequent infusions at a slower infusion rate.

**Preexisting Inflammatory Bowel Disease:** TEPEZZA may cause an exacerbation of preexisting inflammatory bowel disease (IBD). Monitor patients with IBD for flare of disease. If IBD exacerbation is suspected, consider discontinuation of TEPEZZA.

**Hyperglycemia:** Increased blood glucose or hyperglycemia may occur in patients treated with TEPEZZA. In clinical trials, 10% of patients (two-thirds of whom had preexisting diabetes or impaired glucose tolerance) experienced hyperglycemia. Hyperglycemic events should be managed with medications for glycemic control, if necessary. Monitor patients for elevated blood glucose and symptoms of hyperglycemia while on treatment with TEPEZZA. Patients with preexisting diabetes should be under appropriate glycemic control before receiving TEPEZZA.

### Adverse Reactions

The most common adverse reactions (incidence  $\geq$ 5% and greater than placebo) are muscle spasm, nausea, alopecia, diarrhea, fatigue, hyperglycemia, hearing impairment, dysgeusia, headache, and dry skin.
